Proxy voting

Online: via our registrar's, MUFG Corporate Markets, (the 'Registrar') website at <https://uk.investorcentre.mpms.mufg.com/>

Via an App: via the Investor Centre app, which can be downloaded on the Apple App Store or Google Play

By CREST: via the CREST electronic proxy appointment service (for CREST members)

By post: (once obtained (see below)) a copy of the form of proxy should be returned to the Registrar, MUFG Corporate Markets, at PXS 1, Central Square, 29 Wellington Street, Leeds LS1 4DL.

Shareholders can vote electronically via the Investor Centre, a free app for smartphone and tablet provided by our Registrar. It allows you to securely manage and monitor your shareholdings in real time, take part in online voting, keep your details up to date, access a range of information including payment history and much more. You will need to log into your Investor Centre account or register if you have not previously done so. Once you have setup your account you will need to add your shareholding by clicking 'Add Holding' in the 'Portfolio' section and following the on-screen instructions. You will require your Investor Code (IVC) to add your shareholding. You can find your IVC on your share certificate or by contacting our Registrar on shareholderenquiries@cm.mpms.mufg.com or by calling on +44 (0)371 664 0300.

You will not receive a hard copy form of proxy for the AGM in the post. If you wish to submit your proxy appointment via post, you will need to request a hard copy form of proxy directly from the Registrar (contact details below).

All proxy appointments must be received by the Registrar no later than **1.30 p.m. on 4 September 2026**.

Please refer to the explanatory notes to the Notice of the AGM for more information on the appointment of proxies. Voting by proxy prior to the meeting does not affect your right to attend the meeting in person and vote and speak at it.
